I. Statement concerning the participation in the IdeaLab workshop held between 21-25 October 2019:

I hereby declare that:

- a. I have a master's degree (or equivalent degree) or a PhD;

I hereby declare that I consent to the processing of my personal data and I am aware that:

- 3. the NCN shall process your personal data pursuant to Article 6 (1) (a) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 2016, No 119, p.1);

- organising and delivering the IdeaLab workshop if you are selected by the Panel of Experts to participate in the workshop, and
- evaluating the NCN's own tasks, reporting, disseminating information on the NCN's calls for proposals and their results throughout the scientific community, implementing other activities regulated by generally applicable laws and for archiving purposes;

- 7. you may withdraw your consent to process personal data at any time, in which case you will be removed from the list of workshop participants. Your withdrawal of the consent is without prejudice to the lawfulness of processing of personal data pursuant to the consent prior to such withdrawal;
